**BENCHER HONORARIUM:** This contentious issue is unresolved and Convocation remains divided. In January, Convocation approved, by the narrowest of margins (22-21), a proposal to allow for Bencher compensation commencing in June, 2003, after the forthcoming election. The issue sparked real debate within the profession. Strongly held views have been expressed in respect of the principle of payment and what, if any, benefit the profession will realize in return for an additional \$1.0 million spent on regulation. As well, Benchers did not forget that in 1999, the profession was asked and rejected the notion of paying Benchers. There is no empirical data available to determine whether payment of an honorarium will change the composition of Convocation, even if it may encourage more lawyers to seek election. No other Canadian Law Society pays an honorarium as proposed and such a payment may create a problem for the many lawyers' associations whose activities are managed by the enormous effort and dedication of volunteer lawyers. At a special Convocation held to discuss the issue, four separate compensation alternatives were debated and rejected. Undoubtedly, Bencher proponents for a compensation plan will not consider alternatives and the Treasurer has undertaken that upon consideration, it may be appropriate to strike an independent commission to consider and report to Convocation in respect of the implementation of the January policy.

**PARALEGALS:** The Attorney General does not appear to be inclined to resolve this problem by way of legislation. The issue of unregulated paralegals remains an unresolved matter. The public is at risk in dealing with unqualified, uninsured and unregulated paralegals. In order to be proactive, Convocation has approved the creation of a committee which will review developments since the last Law Society report delivered to Justice Cory. It will make recommendations to Convocation, if appropriate, as to the next steps that might be required in order to finally conclude the matter for the benefit of the public and the profession.

**UNCLAIMED TRUST FUNDS:** Since 2001 lawyers have been able to forward to the Law Society, on application, unclaimed money held in our trust accounts. All money collected is held, in perpetuity, and paid out to clients rightfully entitled to the funds. Interest accruing on the money is used to pay the cost of collection and disbursement and any subsequent balance will be paid to the Law Foundation of Ontario. To date, approximately \$450,000 has been paid to the Law Society and no disbursements have been made to any claimants of

the funds. For the New Year, why not clean up your trust account and remit any appropriate amounts to the Law Society to eliminate the annual accounting chore related to those amounts? **INTERJURISDICTIONAL MOBILITY:** In December representatives of eight Law Societies across Canada signed a landmark agreement allowing a lawyer from one province to provide legal services in another with very little difficulty. **RETIRED LAWYERS AS ESTATE TRUSTEES:** Convocation considered the status of lawyers who wish to retire but retain their appointment as an Estate Trustee. To date, such retirement is not possible and those lawyers are required to continue the payment of an annual fee to the Law Society. Convocation was asked to consider a change in the Rules to allow lawyers who wish to retire and remain Estate Trustees to not pay the annual fees, but disclose to clients the implications of retirement and satisfy the Law Society that necessary disclosure has been made. The matter was adjourned for further consultation with the profession.
