**PROFESSIONAL DEVELOPMENT AND COMPETENCE:** The Law Society has developed substantive law resources, practice management resources and programs available to assist members in our professional development. There are currently 51 "products" available, including matters as diverse as bookkeeping, mentoring and time management. Brochures are available for our use and client education. **SOLE PRACTITIONER AND SMALL FIRM TASK FORCE:** This important initiative co-chaired by Mr. Abe Feinstein and Ms. Judith Potter, has begun its work by undertaking the design of a survey to study the pressing issues throughout 2004.

**PRO BONO LAW ONTARIO:** Following a successful conference in 2003, Convocation approved the Law Society's support for a first province-wide pro bono conference to be held in May, 2004. It is expected that this further conference will focus on developing a pro bono culture, social responsibility and legal practice, pro bono models in Ontario and global perspectives on access to justice.

**LAWYERS' FUND FOR CLIENT COMPENSATION:** The Fund exists to compensate clients victimized by lawyers' dishonesty. The number of claims to the Fund at September, 2003 was 195 compared to 181 as at December 31, 2002. The Fund balance as at September, 2003 was approximately \$10.3 million. As a result of the claims experience and fund balance, it was possible to reduce the contribution lawyers make by way of our annual levy from \$280.00 to \$230.00.

**LIBRARYCO INC.:** LibraryCo manages the County and District law library system to develop and enhance skills for the "competent lawyer" in Ontario. There are 48 libraries across the Province staffed, according to size, on a part time or full time basis. In 2003, LibraryCo distributed \$4.6 million in grants and, on average, \$42,500.00 in centralized purchases for each of the 48 law libraries. **SPECIALIST CERTIFICATION PROGRAM:** Recently approved changes in the program are to be implemented in the coming year. For 2003, specialists must complete 12 hours of CLE directly related to their specialty area. However, commencing January, 2004, specialists must complete not less than 50 hours of self study in their specialty area and not less than 18 hours of relevant professional development, at least 6 of which consist of participation in approved CLE programs. By March 31, 2004, specialists must file a report demonstrating compliance during the previous calendar year with the program policies. Failure to do so will result in revocation of certification. By now, specialists should have received an invoice for next year, as well as the particulars of the program effective 2004.
