**TREASURER:** Derry Millar has assumed the position as the Law Society's 62<sup>nd</sup> Treasurer, having been acclaimed in May. Since being elected a Bencher in 1995, Derry has held a wide range of important positions at the Law Society. In his opening comments, Treasurer Millar identified important issues to be dealt with in the next two years, such as paralegal regulation, retention of women in the profession, sole and small firm practitioners, equity and access to justice. On behalf of the Profession, he also congratulated and thanked Mr. MacKenzie for his diligent work as Treasurer in the last 28 months.

**FAREWELL TO TREASURER MACKENZIE:** With the election of the new Treasurer, Gavin MacKenzie's extended tenure came to an end. He assumed the office of Treasurer in February 2006 by a vote of Convocation, following the resignation of George Hunter. Under the leadership of Mr. MacKenzie, the Law Society has overseen the implementation of the Regulation of Paralegals and important advances were made in respect of women lawyers in private practice, sole practitioners and small firms, as well as important reforms relating to the practice of real estate law. Mr. MacKenzie's steady hand assisted the Law Society in maintaining momentum and advancing initiatives not previously thought to be attainable. As a Profession, we have many reasons to be grateful for his years of service.

**GLENN HAINEY (TORONTO):** As a result of the vacancy created in Convocation by the acclamation of Treasurer Millar, Glenn Hainey has joined Convocation on the basis of the votes cast in the last Bencher election.
