LIVING ABOVE OUR MEANS

The good news in this election year, especially for those wanting to be re-elected as a Bencher is that our Law Society membership levy for 2019 is modestly going up by \$18.00 for a new annual fee of \$2,201 per lawyer. However, that nominal increase has only been managed by a recurring, transparent sleight of hand that allocated \$6.3 million from the Lawyer General Fund Balance and surplus investment income in the Errors and Omissions Insurance Fund "to mitigate the fee increase for lawyers". Without those allocations, each of our 42,600 lawyer colleagues would actually have had to pony up an additional \$148.00 to cover the cost of running our regulator. Nowhere in the Budget debate or analysis was Convocation provided with policy options which would have financed Law Society activities based only on the revenue that is actually received. However, the Law Society Budget is well written and is an excellent presentation. In great depth, it provides detailed explanations evidencing a well run, albeit very large, operation that can be found at https://lawsocietyontario.azureedge.net/media/lso/media/about/convocation/2018/convocation-audit-and-finance-committee-report-october-2018.pdf.

To appreciate the order of magnitude, the Law Society regulates about 49,000 legal professionals, with a staff complement of 615 full time equivalent positions and a total annual budget of \$142.5 million with incoming revenue funding only \$133.8 million; hence a deficit. As in past years, the Budget contains lots of material to chew on by aspiring Bencher candidates from which an election platform can be fashioned. (I apologize if your eyes glazed over with that level of detail and zeros, but it is your money.

LICENSING CHANGES

Make sure your elected Benchers and Treasurer know of your views in respect of the ground-breaking changes that affect the profession and public. Following an extensive consultation completed this month, Benchers will meet as a committee in November to discuss the future licensing of lawyers and paralegals. The Report to Convocation by the Professional Development and Competence Committee will be published on the Law Society website (www.lso.ca). Thereafter,

Convocation is scheduled to publicly debate in December which licensing "option" should be followed and wrestle with a decision. If not resolved this may yet become a hotly contested issue in the coming Bencher election.

GOVERNANCE TASK FORCE

Benchers will similarly meet likely in November to debate the extensive work of this Task Force and to address conflicting views of changes needed to make the governance of the Law Society, more effective and relevant. The debate is fuelled by a Task Force Report and an underlying Consultants Report by Hansell LLP. The proposed principal changes reduce the size of Convocation, increase the term a Treasurer serves, implement a succession plan for the Treasurer, reduce the length of time Benchers may be elected and re-organize the work of Committees and the addition of a new Executive Committee.

Many Benchers have already expressed passionately held and diverse, opposing views. I confess that based on my careful review of the material available and the views of others, I am no longer persuaded that it is an appropriate time for Convocation to adopt the governance reform proposed by the Task Force nor seek necessary Government approval to implement the changes. Although it is inherently difficult for me to accept the status quo, I recognize that the current structure as modified with Government support in 1998 has served the public interest well for over 200 years. At this time, no demonstrable case of real benefit has been made out to warrant the sweeping changes proposed. In fact, the process of change may well leave the public and the profession for worse off than can be justified. This is fundamentally important to everyone concerned with regulation of the profession. Following our medical friends, now is the time "to do no harm". Read the material and consider your views:
