



TREASURER MERCER:

Re-elected by a vote of 31 to 22. The 22 Benchers elected as a slate to oppose the Statement of Principles (the "STOPSOP Benchers") had declared support for one member of their group, Chi-Kun Shi. Ms. Shi graciously moved that the election outcome be made unanimous. The election will hopefully ensure a degree of stability and allow for reasonable planning of objectives to be determined by Benchers at a strategic planning retreat scheduled in the fall. In the interim, the Treasurer will consult with Benchers and make Committee appointments during the summer. The appointments will mark the beginning of Benchers' heavy lifting in respect of the many important issues facing the profession. They will also learn about the budget process which will significantly impact the Law Society's ability to fulfill its mandate is to be interpreted by the most recently elected Benchers. Let's see what significant difference is made. Unfortunately, after the Treasurer election, Convocation then descended into a quagmire of conflicting procedural and substantive motions related to the maligned Statement of Principles ("SOP") that graphically display the cultural battle to be fought on a number of fronts in the next 4 years.

STATEMENT OF PRINCIPLES:

The debate on these issues was kicked off with a point of order motion raising a conflict of interest based on the fact that Benchers Klippenstein and Alford are Applicants in an outstanding Superior Court proceeding before the Divisional Court by way of judicial review challenging the SOP. A procedural motion in that court proceeding had resulted in a costs order against the Bencher/applicants personally. The point of order sought to disqualify Benchers Klippenstein and Alford and defer the contested SOP motions until the litigation was resolved. The Treasurer exercised his discretion and ruled there to be no basis for disqualification. In an unexpected turn of events Bencher Julia Shin Doi seconded by Bencher Esquega appealed the Treasurer's decision as a matter of good governance, asserting that the Treasurer erred and there is in fact a conflict of interest that ought to disqualify Benchers Klippenstein and Alford. After a limited debate Convocation voted 41 to 12 that the Treasurer's ruling be upheld so that Benchers could turn to the main event of the day.

All issues were vigorously and passionately debated including motions, amendments and the numerous submissions to Benchers made by lawyers and lawyer associations. By proper procedure, amendments were voted upon before a principle motion. I am very sorry that this report is so complicated by reason of the of the painful route followed by Convocation today. The entire performance was underwhelming.

(1) The initial motion advanced by Bencher Murray Klippenstein, seconded by Cheryl Lean, simply sought to repeal Convocation's December 2016 adoption of the Statement of Principles which mandated that lawyers acknowledge the obligation to promote equality, diversity and inclusion generally and in their behavior towards colleagues, employees, clients and the public. This motion was the fulfillment of a pledge by the elected slate of STOPSOP Benchers. To the great dismay or pleasure of the many lawyers in attendance, Benchers Klippenstein/Lean withdrew their motion. Go figure.

(2) An amendment that had been advanced by Bencher Joseph Groia and seconded by Teresa Donnelly ("the Groia/Donnelly amendment") sought to remove the mandatory element of the Statement of Principles and replace it with a voluntary adoption of a personal and private Statement of Principles on how to best advance the goals of equality, diversity and inclusion in the legal profession and elsewhere. The amendment contemplated that the annual reports will permit licensees to choose whether they wish to disclose whether they have voluntarily adopted a SOP which shall be reported to Convocation. This amending motion was approved 27 to 25. Following withdrawal of the Klippenstein/Lean motion, it was reinstated, as amended, by Benchers Groia/Donnelly. The Klippenstein/Lean motion as amended was defeated. Go figure.

(3) An amendment to amend that had been advanced and seconded by Benchers Charette/Shi that the Groia/Donnelly motion be narrowed to delete any reporting through the annual reports and to Convocation. This amending motion was lost with a vote of 50 to 3. Convocation considered the Groia/Donnelly amendment.

(4) To get a final kick at the same motion, Benchers Horgan/Pollock reinstated the Klippenstein/Lean motion without amendment. The Treasurer adjourned Convocation at 6:30 pm as many Benchers had to leave the proceedings to attend to other pressing matters.

It is now time for Benchers to get to work to reflect the trust put in them by those lawyers who voted. Continued dysfunction as reported above will lead to dire consequences for self-regulation as has occurred in other jurisdictions. There is no Treasurer or Bencher who will feel pride or self satisfaction if the government steps in and revokes a hard earned privilege enjoyed by Lawyers for over 200 years.

Benchers must now roll up their sleeves and find a way to co-operatively get to work. It is far easier to be a dissident without responsibility. Members of Convocation must consider opposing view points and adapt their own reasoning to make tough decisions that will certainly be criticized by others. That goes with the job.

[GOVERNMENT APPOINTED PUBLIC BENCHERS:](#)

The Government has appointed 6 new public or lay Benchers and has reappointed two incumbents - Gerald Sheff and Seymour Epstein. Lay Benchers have historically provided Convocation with a grounding in real-people, non-lawyer reality and offer an important insight to the public interest as must be reflected in the work of the Law Society. The following information has been provided about the new Benchers who joined Convocation in time to vote in the Treasurer election and participate in the Statement of Principles debate:

Robert Bateman - Sudbury

Robert Bateman has been a consultant at Patricia Holdings Inc. since 1983. He specializes in the Forest & Mining Industry and has been a strong advocate for the film industry bringing projects into Northern Ontario. Mr. Bateman is also actively engaged in the City of Sudbury's Job Creation Task force where he helps pursue investment into the City, and has previously served as a director and President of the Sudbury Chamber of Commerce. Mr. Bateman is also an active volunteer for the Sudbury Cancer Society.

Seymour Epstein - Toronto

Seymour Epstein is Chair of Epstein Enterprises Inc., CENetwork Inc., and Kelman Technologies Inc. As well, Mr. Epstein is Chair and President of Law Gardens Inc., and Governor of the Royal Agricultural Winter Fair. Mr. Epstein holds a Bachelor of Engineering from McGill University.

Dr. Benson Lau - North York

Benson Lau is a family physician who has cared for Markham and GTA residents for more than 25 years. Dr. Lau is a former citizenship judge whose duty was to preside over citizenship ceremonies and to educate applicants on the rights and responsibilities of citizenship. He has served as a member of the Toronto Police Services Board and the Ontario Civilian Commission on Police Services. He has also volunteered with charitable organizations, including the Mon Sheong Foundation, Carefirst Seniors and Community Services Association, the Chinese Cultural Center of Greater Toronto and St. John's Ambulance. Ms. Lockhart is a former trustee of Retirement Residences REIT and a former director of the Canada Deposit Insurance Corporation and of Barrick Gold Corporation. She holds the ICD.D designation from The Institute of Corporate Directors. She was awarded The Order of Ontario in 2006 and the Queens Golden Jubilee Medal in 2012.
